Road, Guwahati - 781005 is invited from **Empanelled Vendors** as selected vide office correspondence no. ASSAC/Empanelment of Vendors/41/2022/2024/2058 dated 21/11/2024.

The online quotations will be received up-to 02:00 P.M. of 18.12.2024. The same will be opened on the same day at 03:00 P.M. in presence of bidders or their representatives. Technical Proposal will be evaluated by the Tender Committee as per T & C. Password protected Financial Bid will be opened after evaluation of Technical proposal as per scope of work subject to compliance of T & C and necessary credentials sought for.

Director, ASSAC reserves the right to accept any offer that would be advantageous to the office and not binding to accept the lowest rate or reject all offers without assigning any reason thereof.

Under Scope of Work:

1. Name of the Web based APP: Assam Urban (Waterbodies) App (AURA)

A browser-based system, responsive to web and any mobile device with chrome /edge browser installed into it. The system should be login based and independent users and their credentials should be shared for execution of mapping and marking and viewing activity. The same should also work offline.

1. The system developed will have various internal modules like::

- i. **User Management Module:** To handle creation/deletion of new/old users and assigning roles and responsibilities
- ii. **AURA Data Collection Module:** This module should incorporate Master Plan Data to be shared by ASSAC and that can be overlaid on Google satellite image (any other) for mapping and marking data on existing and newly identified waterbodies to validate the water body points (minimum 4 points) generated in the field by the survey user

- III. Data Collection Dashboard:** This dashboard should highlight the data masterplan wise. The data to be reflected shall be number of waterbodies mapped, marked and newly identified and surveyed along with progress monitored on daily, weekly and monthly basis. A dropdown menu of the masterplan along with list of waterbodies shall be provided.
- IV. AURA Map Visualization Module:** This Module should display the data collected and validated. It should display its attributes. It should have functionality such as basic GIS operations on the fly like zoom, pan, attribute display in table, coordinate finder, spatial search and buffer
- V.** As soon as the Surveyor clicks a zone the following attributed table (to be prepared in lab) should drop down.

2. Terms and Conditions to be followed by the Bidders

1. Proof of concept of similar nature of work along with sample should be submitted with technical proposal.
2. Work order and completion certificate of similar nature of work with technical proposal.
3. Timeline i.e. starting and completion of the similar work.
4. Self certification confirming that the work will be done within the stipulated time. If not, the company will be penalized and the payment will be held up and the work will be transferred to the other vendor who is in the second position / wait listed.
5. Number of resource person with respect to Web-based developer and Application developer.
